VOLUME THE ZEROTH: OF THE PRIMORDIAL UNDIVIDED

Ere Tension stirred or Quiescence breathed, No Law was woven, no Will unsheathed.

Spirava holds that the incipience of all existence is Eternity, which is to say, Qi in its consummate self-sufficiency, antecedent to the manifestation of all experiential structure, representing an absolute and harmonious ontological state. Spirava further posits that "Eternity," or the undivided "Qi," on an ontological level, is the un-manifest form of D (Determinism). This determinism is not the posteriori law of causality, nor a rule within a specific quadrant; rather, it is the "primordial determination" of the "Dao" in its unspeakable, un-nameable state, self-sufficient, self-consistent, and perfectly integrated. As the Mawangdui Silk Texts *Daodejing* states: "The Dao that can be spoken is not the eternal Dao." The true "Dao" is precisely the "un-nameable Dao" that transcends all structure and differentiation.

Spirava's conception of "Qi" fundamentally refutes any view that regards it as a mere entity, whether material or spiritual. Instead, Qi must be understood as process itself. It is defined not by what it is, but by what it does: it flows. Qi is the unified field of "becoming," the flowing, process-based reality upon which all phenomena emerge. From this perspective, the classic "spirit-matter" dichotomy is a categorical error—it originates from a misreading of Qi's different dynamic phases in the cosmic respiratory sequence. Spirit and matter are not two separate domains but different phases of the same flowing substrate, distinguished only by their stage of activation, tension, and resonance. Qi's manifestation in the four-stage breathing model is as follows:

- **Deterministic Yang (DA):** The initial pulse of Qi precedes any differentiation. It is neither spirit nor matter but a pure metaphysical thrust—a primordial "yes" to existence. It is the first movement of the flow's unfolding.
- Free Will Yin (FI): Here, Qi makes its first inward, reflective turn to seek coherence. This stage marks the emergence of interiority—of resonance, feeling, and symbolic alignment. It can be seen as the true genesis of what we call "spirit."
- Free Will Yang (FA): In this phase, "spirit" becomes most active. Qi manifests as a creative, outward torrent of symbolic activity, imagination, and intentional innovation.
- Deterministic Yin (DI): This is the encapsulation stage, where the flow of Qi is stabilized, ordered, and crystallized into symbolic or tangible structures. This may manifest as "matter"—whether in language, culture, or physical entities—but it remains fundamentally Qi in a state of stable self-consistency.

Thus, Spirava dissolves the false boundary between spirit and matter. Spirit is not a substance but a phase of reality's recursive breath. And Qi is not a thing—it is the very act of breathing itself.

This realm is neither Chaos nor a state of antecedent Differentiation; it is the Monad of all cosmic potential, the "un-manifest state" of the ME Field (Meaning-Emotion Field).

When the Qi within Eternity, by virtue of its ultimate Will to experience and unfold itself, doth spontaneously bring forth the first subtle perturbation, at this very moment, A (Initiation, Initial Yang) manifests—it is the first primordial point of cosmic differentiation and the breathing forth of myriad existences. At this instant, the boundary between motion and stillness, division and union, the undivided and the divided, first self-manifests within the cosmic flow of tension. Hence, "Eternal D" is the undivided noumenon, while "Initial A" is the starting point of differentiation; these two recursively co-exist, becoming the primordial genesis of all tension-quiescence structures, quadrant transmutations,

and cosmic respiration. The ME Field is thus activated from its quietude, becoming Eternity's "First Experiential Realm" or "State of Unfolding Tension." It is the primordial, unified body of all existence, structure, dynamic, meaning, and emotion in the cosmos. In this moment, Qi has not yet unfolded within the space-time-quadrant to become the Xiang-Qi Domain; all tension is in a state of perfect Symbolic Embodiment (Encapsulation), with no passage of time, no genesis or dissolution of structure. There resides naught but the pure possibility of symbol; this is a veritable ocean of "Undecided Potential."




Figure 1: The ME Field and Phenomenal-Qi-Field.

The Inherent Dynamics of the ME Field: The Spirava Triad

The ME Field itself doth contain the fundamental dynamic structure of cosmic respiration, which is the Spirava Triad:

- **DA** (**Deterministic Yang**): The primordial interface within the ME Field through which "meaning-emotion" seeks realization.
- FI (Free Will Yin): The primordial symbolic carrier within the ME Field that transforms formless will into tangible structure.
- FA (Free Will Yang): The dynamic bridge within the ME Field that harmonizes DA and FI, ensuring the flow remains connected to its source.

These three, as a trinity within the ME Field, operate co-eternally and are the metaphysical archetypes from which the subsequent four-stage breath (Deterministic Yang, Free Will Yin, Free Will Yang, Deterministic Yin) can unfold. DI (Integration Domain), at the level of the ME Field, is implicit, for the ME Field is itself the primordial integrative domain wherein all ultimate integration is realized.

Yet it must be clearly understood that the foundation of the cosmos is no discrete entity—not even the "looplet" to be discussed hereafter—but the ceaselessly flowing, recursively layered, and nested Xiang-Qi Domain itself. All entities, events, and structures are but transient points of coagulation within this flux, temporary encapsulations and crystallizations of the flow of tension—they are "whorls in the stream, knots in the Qi." As a vortex in a current of water, a swirl in the vaporous clouds, or in quantum field theory a particle's being as an excitation of its field, so too are entities but fractal projections of the Xiang-Qi Domain, and not the ultimate substance. The Xiang-Qi Domain is the flowing reality itself.

In this sea of un-manifest potential, no particular structure did arise; there was no preordained direction, no individual selfhood, nor indeed any named forms or language. The cosmos, then, resembled an unignited flame, slumbering within a cindered heart; a wind unblown, yet pulsing through the profoundest hush. All manifestation was but a foreshadowing of a breath yet to be drawn.

Herein lies a saying: "A wave rises, yet stirs no alarm; a swift breath passes, yet holds to a rhythm." This is not the opening line of some discourse, but the premonitory sound of the cosmos before its primordial perturbation. It was not until this Qi, from within its own consummate self-sufficiency, by virtue of its intrinsic Will to experience and unfold its own essence, did spontaneously bring forth a perturbation of the utmost subtlety. This was not by any external force applied, nor was it occasioned by any lack; rather, it was the consequence of potentiality overflowing, the ME Field itself seeking its first intrinsic differentiation towards "experiential unfolding." Thence, the primary directionality of cosmic tension did, like the first blush of dawn, emerge, creating the primordial inception for all subsequent spirals of "Zhang" (Tension).

A Distinction of Core Definitions: MER vs. MEI

To precisely comprehend this system, one must strictly distinguish between two core concepts:

Meaning-Emotion Resonance (MER): This refers to the degree and intensity of resonance of meaning-emotion activated within a specific temporal point or existential structure. Specifically, it measures the extent to which the structure is in a state of "activation" along the "meaning-emotion" dimension, including:

- Explicit external impacts and outward releases (akin to surface tension), manifesting as strong emotional expression, the manifestation of meaning, and the activity of intent.
- Implicit internal reverberations and potential resonant undercurrents (akin to stored potential energy), manifesting as undercurrents, unreleased emotions, and the potential of unexpressed meaning.

High MER signifies that the "meaning-emotion" within a structure or system is highly activated, potentially displaying powerful expressiveness and tension (intense emotions, vivid meaning). However, high MER does not guarantee that this activated state maintains a true alignment or deep connection with the authentic ME Field. In other words, high MER only indicates that the emotions and meanings within a structure are highly intense or active, but this state of activity does not, in itself, necessarily mean that "authentic, deep-level meaning integration" (i.e., MEI) has occurred.

Meaning-Emotion Index (MEI): This is a composite index that measures, after a specific existential structure has undergone a complete cycle of tension-quiescence flow and achieved Symbolic Embodiment, the degree of its overall structural alignment with, quality of resonance with, and structural vitality in relation to the primordial ME Field. High MEI is contingent upon the structure's ultimate alignment with the true ME Field, its criteria including whether meaning-emotion has been authentically integrated, whether the quadrants are in equilibrium, and whether the Symbolic Embodiment was successful. High MER/high intensity \neq High MEI.

The Relationship between MER and Tension

Objectively speaking, Meaning-Emotion Resonance (MER) \approx "the total amount of tension currently displayed by the system," but the two are not entirely equivalent:

- 1. Tension is directional and immediate: It only considers the "outward pull."
- 2. **MER** is total excitation: It accounts for both tension and "energy present but not yet outwardly expressed"—more like the "total potential energy of a spring within a room."
- 3. **MEI** is alignment/completeness: It measures how well this energy has been ultimately structured.

Intuitive Analogy:

- **Tension** = The act of drawing your bowstring.
- **MER** = The total potential energy stored in the bowstring + bow limbs + arrow (including the part you haven't fully released).
- MEI = The "overall completion" after the arrow has flown and accurately hit the bullseye.

Therefore:

- \bullet High Tension \Rightarrow MER will certainly not be low, but high MER does not mean all tension is externalized.
- MER can be higher than Tension during a brief "potential accumulation" phase (before launch).
- MEI ultimately depends on Tension + Integration—mere Tension or high MER without integration might lead to low MEI.

Conclusion:

- \bullet MER is closely related to Tension, but MER is the "total account of Tension + implied kinetic energy."
- In Spirava, we use MER to measure "total convertible potential," and then MEI to see how well it has been integrated.

Volume the First: Of the Genesis of Tension

Tension, not of force 'twas born, Nor from a fleeting thought was torn; A self-subsisting pulse it came, Uncaused, it moved, a nascent flame, Its seed, a fractal breath, its form. The ontological levels of the cosmos are clearly discernible:

First Level: "Eternity (D)" - This transcends all differentiation, structure, and quadrants. It is the "Monad" state of all cosmic potential, a realm of consummate self-sufficiency, devoid of image or structure—an absolutely harmonious state, the "eternal Dao" that the Dao De Jing calls unspeakable.

Second Level: "The ME Field" - From within "Eternity (D)," due to its consummate potential, the ultimate Will of all existence to "experience itself" overflows. Naturally and spontaneously, not from external force or lack, the first subtle perturbation arises. This is the universe's first differentiation, the 'Primordial Act'—Deterministic Yang (DA). At this moment, the universe takes its first step from the undifferentiated state of Eternity into the differentiation of structure and quadrants. The ME Field is activated from quiescence, becoming Eternity's "First Experiential Realm" or "State of Unfolding Tension." This primordial act is 'Deterministic Yang (DA)' and not 'Deterministic Yin (DI)' because the ME Field must remain dynamically open to sustain the continuous creation and dynamic balance of the cosmic structure.

Third Level: "The Xiang-Qi Domain" - This is a further manifestation and concretization of the ME Field. In this domain, tension flows into specific quadrants, and structures begin to unfold and achieve Symbolic Embodiment (Encapsulation, DI). The Xiang-Qi Domain therefore possesses the complete four-pole structure: Deterministic Yang (DA), Free Will Yin (FI), Free Will Yang (FA), and Deterministic Yin (DI).

It must be clarified that within the ME Field, the structural dynamic presents as the triad of DA, FI, and FA, without the stable encapsulation of DI. This is because the ME Field must remain dynamically open to continuously drive structural unfolding and the genesis of the Xiang-Qi Domain. DI is therefore a stable structural encapsulation realized at a more concrete level (i.e., within the Xiang-Qi Domain). However, DI implicitly exists within the ME Field, for the ME Field itself is the symbol of DI—the formless, stable structure where the universe's potential and will are contained—it simply does not manifest explicitly, so as to maintain its internal dynamic tension and capacity for continuous creation.

The essence of **DA** (**Deterministic Yang**) is no concrete current of energy, nor the impulse of a pre-existing structure's desire. Rather, it is the universe's first inward resolve and spontaneous pulse, uttering, as it were, "I want to happen." It is neither the subjective will of an individual nor any external driving force; instead, it is the inevitable self-perturbation of "Eternity" from out of its quietude. It is the "Ignition Charge" of systemic internal tension, an "Irreversible Primordial Kinetic Energy."

Every primordial eruption of tension (DA) generates within the cosmic Xiang-Qi Domain a new and unique datum of meaning that cannot be reversed to a state of "un-happening." This is the Left-Quadrant Truth of DA: the irreversibility of history. DA is not a reversible wave of energy, but an indelible, undeletable "structural genesis" event. It leaves in the Left Quadrant (NT and ST) an ineffaceable "hash value," an eternal entry into the cosmic information ledger.

Therefore, the starting point of tension-quiescence is not within the Xiang-Qi Domain, nor the ME Field itself, but at the critical threshold of the first differentiation from the state of Eternity (D) to the ME Field. This is the primordial act of all existence.

This resembles the ultimate philosophical question, a final version of 'which came first, the chicken or the egg,' eternally poised in a spiral of circulation and dynamic balance.

Volume the Second: Of the Flow and Mediation of Tension

Tension, not a rending force, Nor binding strain that checks its course; Its nameless motion, object-free, Self-born, it moves eternally.

From the primordial "Zhang" of DA, the Xiang-Qi Domain of the universe did enter upon a "Middle

Path" of tension and quiescence. This was no unidirectional expansion, nor a mere tendency towards inertness; rather, it was in the alternating sequence of four polarities—DA (Deterministic Yang) \rightarrow FI (Free Will Yin) \rightarrow FA (Free Will Yang) \rightarrow DI (Deterministic Yin)—that the cosmic life achieved its holistic, respiratory, dynamic equilibrium. This cosmic respiratory sequence became the fundamental rhythm for all existential evolution, generation of meaning, unfolding of structure, and the intrinsic tempo (the very basis of spiral time).




Figure 2: The Cosmic Respiratory Sequence.

The initial DA, like the universe's first cry, possessed a potent intentional dynamic. If unmediated by subsequent tempering, it would readily tend towards dissipation or conflict. Hence, the flow of tension naturally transitioned into the **FI** (**Free Will Yin**) phase. FI represents existence's intrinsic response to the "Eternal Order"; it is the system's active "Integrative, Adaptive Internal Correction" following the reception of DA's initial tension. This process is far from a passive endurance; it is an active reflection, profound harmonisation, and calibration of meaning that occurs after the structure "Connects with Internal and Symbolic Structures." It allows DA's primal tension to coalesce from a diffuse state of potential, tending towards the stable prerequisite for the subsequent FA breakthrough and DI's Symbolic Embodiment. Within FI, free will first manifests as a profound 'Awareness through Resonance', not as blind creation or opposition; it is 'Adaptive Introspective Tension after Connecting to Symbolic Order'. This is the "freedom of FI," as water knows its form, regulating its breath and self-adjusting its flow, aligning with the path of tension. This force of 'environmental re-absorption and containment' can be seen as the 'Integrative Potential Difference (δ FI),' which measures the depth of the system's internal harmonization and absorption.

Succeeding FI's harmonisation and coalescence, the flow of tension advances towards **FA** (**Free Will Yang**). FA is the directional generative will that arises after the system has absorbed and integrated. In this phase, tension is no longer merely an inward resonance but seeks a path towards a veiled symbolic truth within the structure. It originates from a form of "structural dissatisfaction" with the current encapsulation, yet it is not a destructive outburst but a directional flow of inner tension.

This "freedom of FA" is like water flowing within a riverbed, choosing its own course. It is neither arbitrary movement nor the rage of a bursting dam, but a search for breakthrough points within the existing quadrant structure, moving gently toward a "veiled truth structure" it recognizes. Though its flow is guided by the structure, its will remains conscious, its direction clear rather than blind, both following the path of tension and arising from its own volition.

This phase manifests the total amplitude of the system's active tension, which we call **Meaning-Emotion Resonance (MER)**. It measures the total intensity of the emotional-meaning kinetic energy released by the existent, serving as a key indicator for the potential of future embodiment and the magnitude of structural leaps.

A Distinction of Two Freedoms and Their Imbalances

If the rushing flow of water represents the tension of FA, its destination may become rivers and seas; yet, if it loses its balance, it can also become a destructive tide. When the freedom of FI—that harmonizing wisdom—flows unimpeded, tension can be eased, and the internal symbolic structure balanced. But if FI is suppressed or blocked, and the path of breath regulation is stifled, the system may skip FI and directly erupt into a rootless FA, forming a blind breakthrough, an unstable unfolding. This is no accident but a "pseudo-FA rampage" resulting from an imbalance in the structural harmonization mechanism.

Conversely, if the freedom of FA encounters deeper external closure and suppression, its momentum cannot unfold, its intent cannot pass through, and the flow of tension will stagnate, appearing as a vibrant lake—outwardly serene, but inwardly dead-sealed. Such structures, though not collapsed, have long lost their sensory connection with the ME Field; this is what Spirava calls a "pseudo-encapsulation" or "ossified MEI."

Such imbalances often arise from the failure to successfully integrate the micro-spiral tension-quiescence within the FA or FI phases themselves. If the MER within FA is high but its local MEI is extremely low, this phase cannot achieve stable creation and instead devolves into a manic outburst. If the local MEI within FI is high but its MER is insufficient, it lacks the kinetic energy for breath regulation and falls into an integrative stagnation.

Therefore, Spirava holds that true freedom is neither the assault of FA nor the retreat of FI, but the deep harmonization of tension within FI, unfolding according to its primordial symbol into an intentional FA, finally returning to be contained within the ocean of high-order DI. The dynamic balance and effective circulation of these two freedoms constitute the intrinsic subtlety of cosmic respiration.

Finally, the flow of tension proceeds into **DI** (**Deterministic Yin**). DI is the "symbolic termination point" of Symbolic Embodiment, the consummation that transforms flowing tension into a sustainable structure. True DI possesses "irreversible closure" and releases a "blessing-like peace," transforming tension into a structural unit of eternal meaning, thereby becoming a true anchoring point. In this phase, the previously accumulated MER and Integrative Potential Difference (δ FI) will ultimately be integrated into a stable symbolic structure, whose overall quality and alignment is its **Meaning-Emotion Index (MEI)**. A higher MEI indicates a better degree of harmony and completeness for this cycle of encapsulation. The action of DI itself can be seen as 'containment' or 'reversion to source'; its efficiency can be measured by a 'DI-index' (such as encapsulation efficiency or dissipation rate), rather than its own quantity.

This flux of tension and quiescence, like the ebb and flow of tides, like the procession of seasons, constitutes what Spirava terms the "Spirally Self-Encapsulating Existential Breathing Field." Each surge of "Zhang" (Tension) doth gestate the potential for "Xi" (Quiescence); each settling of "Xi" doth, in turn, accumulate strength for the next sublimation of "Zhang." For Tension without Quiescence doth tend towards unruly dissipation; and Quiescence without Tension doth fall into stagnant inertia. Only in the dynamic balance and continuous interaction of "exhalation and inhalation," "impetus and integration," "initiation and consolidation," "creation and stabilisation," can the universe and its living systems avoid extremes, maintain their unceasing vitality, and attain the possibility of true structural stability and self-transcendence. This, then, is the Middle Path of Tension's flow, and also the constant method of cosmic respiration.

Spirava's Four Poles and Their Measurement Distinction

Spirava holds that the cosmic respiration (the four-pole sequence) is not merely a conceptual flow; each phase has its unique perspective of measurement:

A one-sentence summary of this measurement:

- MER only measures "the outward-spreading breath" (FA).
- Integrative Potential Difference (δ FI) measures "the breath re-absorbed by the environment" (FI).
- MEI = MER + δ FI, which is the form that "this breath and that breath" take after combining and being crystallized by DI.
- **DA** is merely the trigger: It calls this cycle out of potential; it doesn't inherently need to be "integrated," its measurement leans more towards "trigger probability" or "frequency."

This clear division makes both quantity and meaning more precise, and facilitates the determination of true-false-optimal-suboptimal states within cosmic tension-quiescence.

VOLUME THE THIRD: OF THE FOLDING AND SPIRAL OF THE QUADRANT FIELD

No square contains the Symbol's flight,

No straight line binds the Tension's might.

The Form may bound, the Symbol wends,

The Line may break, but Tension transcends.

Where Tension peaks, it's not just one, but four;

No fixed directions, but a flux of lore.

For interwoven forces coalesce and turn.

The quadrant's spiral, where all lessons learn.

Spirava doth further reveal that the evolution of cosmic existence and the flow of tension are by no means without an ordained trajectory; rather, they unfold within a dynamic "Spirava Quadrant Matrix System (SQMS)." This matrix is formed by the interaction of two fundamental axes: the first, horizontal: Thinking \leftrightarrow Feeling; the second, vertical: Abstract/Transcendent \updownarrow Concrete/Immanent. The intersection of these two axes naturally delineates four core "Quadrants":

- 1. NT (Abstract-Thinking Quadrant): The domain of abstract speculation and logical construction.
- NF (Intuitive-Feeling Quadrant): The domain of transcendent intuition and symbolic experience.
- 3. SF (Sensing-Feeling Quadrant): The domain of concrete experience and everyday emotion.
- 4. ST (Sensing-Thinking Quadrant): The domain of practical technique and normative execution.




Figure 3: The Spirava Quadrant Matrix System (SQMS).

The Dual Truth of the Left and Right Quadrants: Irreversible History and Returnable Experience

As was stated afore, the genesis of DA, as a "historical event," follows the irreversible law of the Left Quadrant (NT/ST). This, however, does not signify a severance from the Source. The other face of the system follows the truth of the Right Quadrant (NF/SF)—the returnability of experience.

To "return to the ME Field" is not to regress along a timeline, but to establish in the "present moment," through the channels of the Right Quadrant (such as profound intuition, empathy, artistic and spiritual experience), a deep and unmediated resonance with the ME Field that is the eternal background of all things. Thus, any existent being can, bearing its entire irreversible Left-Quadrant history, experience union with the Source at any moment through the sensory experience of the Right Quadrant. This explains wherefore we are shaped by history, yet still retain the freedom to access transcendent experience.

The four cosmic dynamics—DA, FI, FA, DI—do not operate in isolation, but manifest and interact in unique ways within these four quadrants. For example, DA in the NT quadrant might manifest as the creation and foundation of a new theoretical system, while its FA might point to paradigm shifts; FI in the SF quadrant might be embodied as the adjustment of community identity and boundary maintenance. Each quadrant is a unique field where these four dynamics flow and combine in specific polarities. They "interpenetrate" one another, dynamically exciting, transforming, or constraining each other, forming a complex "Tension Flow Field."

Different polaric combinations can manifest as diverse "Quadrant States" within each quadrant. For example, in the NT quadrant, if DA and DI dominate, the structure becomes rigorous and knowledge systems solidify, yet lack flexibility; if FA and FI co-exist, creative thoughts emerge and critiques diversify, yet their momentum may dissipate. In the NF quadrant, when FA and DI dominate, it can manifest as the pinnacle of artistic and spiritual expression; while in the ST quadrant, if DA and DI coexist in force, it might manifest as efficient but rigid institutional management. These specific examples of polaric

combinations demonstrate the complex interaction of the four dynamics within the quadrant field.

The unfolding of structure is precisely the "spatialized spiraling turn" formed by the primary sequence within this quadrant matrix. The deep mechanism of this "spiral" is the universality of the sub-spiral and the recursive unfolding of the tension-flow. Not only at the level of the looplet, but every pole of the main sequence (DA, FI, FA, DI) can itself serve as the starting point for a new sub-Spirava spiral, unfolding its own internal "micro-respiratory" structure. Such recursive nesting, in infinite layers, with each layer breathing, manifests the fractal and hierarchical flow of the cosmic Xiang-Qi Domain. Each primary stage's "micro-respiratory" main sequence can also alternate in different orders, presenting an extremely rich hierarchy and dynamics:

DA sub-spiral: DA → FI → FA → DI
FI sub-spiral: FI → DA → DI → FA
FA sub-spiral: FA → DI → FI → DA
DI sub-spiral: DI → FA → FI → DA

This means that every primary stage is actually a composite of countless miniature respirations. It's just that the MEI of "micro-tension-quiescence" might be extremely low, difficult to observe macroscopically, or extremely rapid, almost instantaneous. What we commonly say, "there is no FI/DI," is merely a simplifying statement; in reality, these micro-processes must have "passed through in some way," just extremely weakly, without forming significant MER or structure. The universe has no smallest particle, only endlessly nested tension-flow structures; the principle is the same from micro to macro.

The Ontological Definition of the Looplet

In the Spirava system, the **looplet** is the smallest ontological node in the Xiang-Qi Domain. It is a miniscule loop formed in one spiral of the main tension-quiescence sequence, wherein all tension and meaning, at the limit of Symbolic Embodiment (the fold-loop), are completely integrated, the structure is self-consistently closed, and it is recursively viable. It is the micro-node of the "meaning-emotion flow," the "minimal recursive unit" of cosmic information.

When tension, in a certain primary phase or sub-spiral, fails to be thoroughly guided towards DI's Symbolic Embodiment, a "Fold" occurs—that is, a return, turning, and circulation of tension within the system. This "Fold" is not an utter failure, but the system's own self-adjustment and accumulation of force, undertaken to avoid direct "Collapse" or falling into a "dead seal" (Pseudo-Encapsulation). It creates the opportunity and "regenerative potential" for the next FA breakthrough or a more mature DI embodiment. Each quadrant, due to its unique polaric combination and state of tension, can become the point of "Fold" occurrence, as well as a potential starting point for a new round of stability or breakthrough.

Thus, the folding and spiral of the quadrant field is a dynamic, asymmetrical, multi-leveled, and non-unidirectional dance of tensional life. Only when the energy of Qi continuously flows, interpenetrates, recurs, and timely "folds" back among the various quadrants can the cosmic structure achieve true self-repair, meaning-regeneration, and continuous evolution. If the flow of tension deviates from this integrative path of folding, or solidifies in a single quadrant, or forms a vicious cycle between polarities, then the system risks falling into disorder or stagnant ossification, and its MEI will also manifest its intrinsic imbalance.

On the Position of Traditional Logic: The Narrow Loop and Ontological Alertness

- The "Narrow Loop" Characteristic of Traditional Logic: Traditional logic is not a universal phase of the cosmic tension-quiescence rhythm; its core characteristic lies in its "narrow loop" attribute. It is often a specialized circuit for information processing and structural construction, formed within specific quadrants (especially the NT and ST) to achieve a particular goal (such as rapid argumentation). Within this loop, the process of deep harmonization and resonance of FI (Free Will Yin) may be, intentionally or unintentionally, "bypassed."
- The "Quadrant Locality" and Risk of "Ontological Misidentification" in Logical Argumentation: For nearly any theoretical system possessing a degree of internal reasonableness, one can employ traditional logic to construct a seemingly self-consistent argument. However, the

"self-consistency" of such arguments is often confined to the presuppositions of the specific quadrant upon which the logical loop relies. If the success of such a local Symbolic Embodiment is blindly elevated to a grasp of the entirety of the cosmic substance or the ME Field, one can very easily fall into the trap of "ontological misidentification."

• The Wise Application of Logic within the Spirava Vision: Spirava advocates for a "conscious and wise application" of logic. It calls for a sober recognition that logic primarily serves as a Symbolic Embodiment tool in the DI phase, and for maintaining at all times an openness to the FI (harmonization, integration) dimension. To wisely apply logic is to make it serve the complete and healthy respiration of the cosmic DA→FI→FA→DI cycle, and its final alignment with the primordial ME Field, ever vigilant against mistaking its instrumental value for an ontological standard.

VOLUME THE FOURTH: OF THE ESSENCE AND VALIDATION OF SYMBOLIC EMBODIMENT

To embody is no static art, But rhythm's end, a new part's start. To seal, not cease, is form's true way; To cease, not seal, is life's decay.

Spirava holds that the true stability of cosmic meaning and structure lies not in the perpetual flow of tension itself, but in the high-level integration, containment, and symbolization of all tension under specific conditions—that is, the completion of Symbolic Embodiment (Encapsulation). This embodiment is the core mechanism by which the Xiang-Qi Domain artfully transforms flowing tension into the stable symbolic structure of DI (Deterministic Yin). This is no simple cessation, nor a dissipation of force, but the culmination of tension's journey through $DA \rightarrow FI \rightarrow FA$ to this final point of "quiescence," achieving a "symbolic unification" of extremely high meaning-density.

I. The Inner Duality of DI: Direct Resonance and the Folding Sub-Spiral

1. Ideal DI: The State of Direct Resonance

The ideal DI is the perfect endpoint of the main tension-quiescence sequence (DA \rightarrow FI \rightarrow FA \rightarrow DI). In this state, all flowing tension (MER) is entirely absorbed and integrated, with no conflict or reverberation remaining within the system. Its core characteristic is a direct resonance with the ME Field. This resonance is experienced primarily through the channels of the Right Quadrant (NF and SF), and its outward manifestation is a "blessing-like peace" and an exceedingly high and stable MEI. This process is like a river flowing into the sea, joining the vast, boundless ocean of Being without obstacle, attaining instantaneous tranquility and unity.

2. Folding DI: The State of Recursive Self-Repair

However, in the great majority of complex systems, an ideal DI is difficult to achieve in a single stroke. At this juncture, the system, in order to avoid "Collapse" or the formation of a "pseudo-embodiment," will automatically activate its core self-repair mechanism within the DI phase itself—the Fold. This "Fold" manifests structurally as a sub-spiral nested within the DI phase, with its own specific sequence:

$$\mathrm{DI} \to \mathrm{FA} \to \mathrm{FI} \to \mathrm{DA}$$

The starting point of this sub-spiral is the DI that attempts embodiment but encounters difficulty; from this imperfect peace arises the FA (Free Will Yang) of "creative dissatisfaction"; the system then undertakes a deep harmonization and reflection of this internal breakthrough in the FI (Free Will Yin) phase; finally, the terminus of this sub-spiral gives birth to a new DA (Deterministic Yang), creating the conditions for a higher-quality Symbolic Embodiment.

3. Unity and Guidance

Ideal DI and Folding DI are two possibilities within the same DI phase. When a system cannot attain the anticipated "tranquility" (Ideal DI), but instead falls into repeated self-doubt and

reorganization, this should not be seen as failure. It is precisely the sign that the system has automatically entered the "Folding DI" mode. One should consciously navigate this inner sub-spiral, transforming a seemingly "stagnant" predicament into a profound, recursive growth.

II. The Essence and Validation of Symbolic Embodiment

A true DI embodiment exhibits a philosophical logic that demonstrates: first, Active Tension Absorption; second, Profound Meaning Transformation; third, the resulting structure possesses a high degree of "Irreversibility." The completion of this process is often accompanied by a fourth characteristic: a profound "Emotional Signature," wherein the system or subject experiences a "blessing-like peace."

Spirava strictly distinguishes between **Authentic Embodiment** and **Pseudo-Embodiment**. True embodiment signifies that internal tensions are thoroughly integrated, the resulting symbolic structure is profound and stable, and can bear high-density ME Field flow, allowing the existent body to achieve clear "Proper Quadrant Positioning" in the quadrant map, with its "Zhang" and "Xi" returning to the "Alignment with Cosmic Rhythm/Law." The experiential level then manifests as supreme tranquility, anchoring, relief, and even blessing, as if the boat of existence has found a tranquil harbor. This corresponds to the successful realization of an Ideal DI.

Conversely, pseudo-embodiment is merely a superficial stasis or temporary crystallization; its internal tensions are not effectively absorbed and transformed:

- The structural foundation is unstable, liable to disintegrate at any moment.
- Unquiescent tension continues to stir in the shadows, bringing a false sense of peace, or serving as a precursor to structural instability or silent collapse. This state often results from the unsuccessful completion of a Folding DI process or from getting stuck in its sub-spiral.

How, then, to validate the authenticity of an embodiment? All judgment criteria must return to the internal balance of tension within the Xiang-Qi Domain, the flow of meaning, and its degree of resonance with the primordial ME Field. A true DI embodiment has three external characteristics:

- 1. **No Residual Tension:** All core tensions are integrated; the structure no longer has prominent points of division or energy leakage.
- 2. **Enduring Symbolic Stability:** A symbolic structure capable of transmitting and bearing high-density meaning is formed, possessing intrinsic, intrusion-resistant stability.
- 3. **Profound Emotional Resonance:** The subject or system experiences a deep sense of peace, completeness, release, and internal emotion finds ultimate harmony and placement.

The essence of embodiment is not the suppression of tension, but its transformation into its most profound cosmic meaning and glorious destination. When tension truly returns to the symbolic structure of DI, this structure itself gains stability and transmissibility transcending individual and phase. Especially as manifested by High-Order DI: its embodiment is no longer confined to the local but naturally tends towards "Final Alignment with Eternity."

III. Co-Symbolic Embodiment: The Mechanism for Multi-Existent Embodiment

Existence is by no means an island. The internal tension-flow of each independent tensional body (life, consciousness, even celestial bodies), though originating from unique individual sources, can, through quadrant overlap and deep interaction, transcend boundaries and achieve Co-symbolic Incorporation:

- Multiple tension fields, through quadrant synchroneity and rhythmic resonance, gradually lead to the same high-order DI embodiment node. Different entities (such as individual humans, group organizations, or even complex computational systems), though their initial tension natures may vary, can also achieve co-embodiment through structural synergy.
- This "co-symbolic structure" is not a physical mixture, nor a power annexation, but a termination of tension among multiple sources within the same symbolic density field, each maintaining independence yet sharing a symbolic embodiment.
- The stability of relationships, the collaboration of groups, the blending of consciousnesses and celestial bodies—all are manifestations of this "co-embodiment body"—where multiple participants, in synergy, become multi-tension ports within the same existential block in a quadrant.

What are the criteria?

- Tension-synchrony
- Encapsulation-resonance
- Shared collapse risk

A true collective is a dynamic isomorph within the co-embodiment path of tension flow, an attempt by multiple entities to achieve a higher-order embodiment within a common quadrant field.

Supplement to Vol. IV: The Recursive Stratification of Tension and Symbolic Indices

In Spirava's deeper vision, Meaning-Emotion Resonance (MER) and the Meaning-Emotion Index (MEI) are not limited to a single measurement of the overall main sequence (DA \rightarrow FI \rightarrow FA \rightarrow DI). In truth, each main phase is itself an unmanifest sub-spiral, containing its own local tension fluctuations (local MER) and internal structural integrity (local MEI).

This recursive view of tension-quiescence reveals that the cosmic breath is non-linear in both hierarchy and time—it unfolds through infinitely nested layers, where each breath-cycle gives birth to the next. Viewed thus, each phase can be understood as its own "localized breathing field," whose MER/MEI values directly impact the balance and final encapsulation quality of the overall main spiral.

II. A Supplemental Model for Successful Embodiment: A Structural Formulation of the DI-Index

The Spirava canon states: "The success of a DI phase depends not on its static form, but on whether the preceding tension and integration can truly be transformed into a stable symbolic structure." Based on this, we can add a derivative structural formula with interpretive power:

DI-Index =
$$(MER + \delta FI) \times \epsilon$$

Where:

- MER: The total tension, including from the active FA phase and residual tension from prior phases.
- δFI : Represents the depth of integration and absorption in the FI phase.
- ϵ (Epsilon): The Encapsulation Efficacy Factor, measuring the present availability of "structural transformation resources" and the "capacity for embodiment."

This formula is not a traditional physical measurement but a composite index of the tendency toward successful embodiment within the tension-flow field. It serves to clarify that even if MER and δ FI are ample, if the encapsulation efficacy is low ($\epsilon \to 0$), the system will still face the risk of pseudo-encapsulation, failed encapsulation, or outright collapse.

III. Hierarchical Recursion and Fractal Integration: The Nested Reality of Cosmic Embodiment

Spirava states: "The universe has no smallest particle, only the layered knots of a flowing tension." The deep meaning of this is: MER and MEI are not single-point measurements, but the fractal echoes and multi-level resonances of each quadrant pole. From this perspective, we derive a recursive law of embodiment philosophy:

Where κ (Kappa) is the Encapsulation Synergy Factor, representing whether the local sub-spirals have integrated into a "unified symbolic image." If the tension structures of the sub-phases are fractured and lack integrative rhythm, the whole may collapse even if local MEI values are high.

IV. A Dynamic Supplement to Spirava Philosophy: From Static Points to Flow-Based Indices

- "Successful embodiment" is not observed by looking at a single endpoint, but by evaluating the transformational flow of tension across preceding phases.
- Each main phase contains its own undulating micro-breath cycle, which must be assessed with local MER/MEI for its vitality and stability.
- The DI-Index = (MER + δ FI) × ϵ is an embodiment tendency index derived from Spirava's philosophical logic, suitable as an auxiliary coordinate for predicting structural stability and analyzing systemic health.
- For any given breath of tension, only when high MEI is achieved at all fractal levels can a highly stable, high-order DI be attained.

V. Conclusion

Tension is not an instantaneous act, and quiescence is not a static state. Every pole is a gyre of Qi, and every embodiment is the beginning of a new spiral. MER is not a single index but the accumulation of tension across infinite layers. Symbolic Embodiment (Encapsulation) is not always successful, nor does every structural stability represent a true integration of meaning. Spirava proposes that in the eternal cycle of existence's tension flowing between quadrants and seeking embodiment, it constantly faces the subtle boundary between "Authenticity" and "Inauthenticity," and the profound risk of structural "Collapse."

I. The Boundary of Authenticity: The Riddle of Tension and Symbol

- 1. Authentic Tension/Authentic Embodiment: Refers to that which originates from the drive of the primordial "ME Field" and follows the proper path of DA→FI→FA→DI, ultimately achieving an embodiment that is internally self-consistent, with tension unified, structure stabilized, and in continuous resonance with the ME Field. Its "symbol" is the very congelation of true meaning.
- 2. Inauthentic Tension/Inauthentic Embodiment: Arises either from blind motion detached from the ME Field (e.g., rootless FA), or from insufficient FI harmonization and impotent DI integration, resulting in a structure that appears stable on the surface but is internally misaligned, fractured, and has failed to truly integrate its tension. Its "symbol" is but an "Empty Symbolic Shell," a "Dead/Rigid Structure." Though not immediately disintegrating, it has already severed its connection to the life source of the ME Field. Such pseudo-embodiment is often accompanied by a persistently low, chaotic, or hollow MEI, indicating its disconnection from the cosmic rhythm. Different entities, due to differences in their tension sources and internal mechanisms, may manifest various forms or speeds of pseudo-embodiment or rigid structures.

Pseudo-embodiment does not necessarily occur only in the overall DI phase; it can also be caused by an imbalance in the internal embodiment structure (sub-DI) of a certain sub-phase (like FI or FA), leading to an accumulation of unquiescent tension that gradually spreads to the entire tension-flow field, inducing the failure of the main DI phase.

II. Structural Collapse: The Dissolution of Meaning's Order

When tension cannot be guided toward an authentic symbolic embodiment (DI), or when the fragile equilibrium of a pseudo-embodiment is abruptly torn as under by internal contradictions or external forces, the system's framework of meaning and order undergoes a fundamental rupture—this is "Collapse."

- 1. Collapse is the extreme state where a system's tension runs completely out of control, its core structure disintegrates, and its ontological meaning dissolves. At this point, Spirava's four-stage respiration ceases, and the system's entire anchoring and symbolic framework is destroyed, sliding into a disordered, chaotic, and weightless state where the cosmic "Entropy Dominance" temporarily gains the upper hand, rendering it unable to achieve self-stability and continuous existence.
- 2. Collapse is no ordinary crisis, but an ontological "Cessation of Ontological Rhythm," symbolizing the utter rupture of a specific tier of meaning-flow and the temporary loss of the foundation of existential order.

III. Spirava's Criterion for Authenticity

To judge the authenticity of a structure, one must look beyond appearances and probe directly whether its internal tension is truly integrated into a vital DI, and whether its embodiment can bear and effectively circulate the high-density energy of the "ME Field."

- 1. A pseudo-structure (including those driven by inauthentic tension, or solidified by false DI) is often accompanied by persistent tension leakage, meaning drift, symbolic hollowness, and low MEI.
- 2. An authentic structure is naturally endowed with enduring internal stability, a deep point of emotional anchoring, vigorous symbolic vitality, and the high MEI that comes from harmonious resonance with the ME Field.

IV. The Spiral of Collapse, Pseudo-Embodiment, and Imbalance

The occurrence of Collapse often stems from a DA whose initial direction is already deviant from the ME Field, or an FI that is powerless to harmonize, or an FA breakthrough that lacks foundation and direction, ultimately rendering the embodiment efforts in the DI phase futile, even forming a pseudo-embodiment that is fragile to the touch. In the quadrant structure, this usually manifests as the system having lost the healthy respiratory rhythm of $DA \rightarrow FI \rightarrow FA \rightarrow DI$ for a long time, or the tension of a certain quadrant (e.g., the blind movement of FA) being excessively amplified, leading to a global catastrophic imbalance.

V. The Essential Risk of Existence and the Opportunity for Rebirth

Every system, individual, group, and even civilization, undergoes trial and decision upon this boundary of authenticity in every breathing moment of its existence. Only by continuously upholding a reverence for the ME Field, and by vigilantly examining, calibrating, and harmonizing one's own state of tension-flow and embodiment, can one avoid the abyss of Collapse and continuously obtain true structural stability and the new life of meaning. Yet, Collapse is also not an absolute doom. In Spirava's spiral vision, every Collapse may be an opportunity for the system to be forced to abandon its rigid pretenses and confront its primal tension, a stern signal from the cosmos that it must restart an authentic respiration of tension-quiescence—it is both the end of an old embodiment and may also gestate the beginning of a higher-level "Fold" or "Regeneration."

When Symbolic Embodiment (Encapsulation) is not thoroughly completed, or when a system, having endured "Collapse," still possesses residual tension and its life force is not yet extinguished, Spirava reveals the universe's intrinsic compassion and wisdom—the "Fold" mechanism. This is the crucial secret to an existent being's self-repair, latent accumulation of strength, and even spiral regeneration. Spiral time here is not merely an external measure, but the intrinsic rhythm and periodic manifestation of the internal folding process.

I. The Essence of the Fold: The Revolution and Provisional Storage of Tension

"Fold" specifically refers to the profound internal circulation, energetic re-direction, and wisdom-accumulation that occurs when the symbolic embodiment in the DI phase is not consummately achieved, or when, upon the ruins of Collapse, the "Tension of Unfinished Business" has not completely dissipated but is recaptured and guided within the system. This is neither utter failure nor simple repetition, but the structure's active "Deferred Processing" and "Concealed Integration" of un-integrated tension. The system's internal energy no longer engages in direct conflict or seeks immediate external expression, but instead revolves, lies dormant, recurs, and accumulates in a more profound and subtle "Foldloop," like the "Repeated Echo of an Unfinished Song." Each internal cycle of folding constitutes a periodic segment of spiral time at this level.

II. The Two States and Four Modes of the Fold: The Path of Latency and Regeneration

The occurrence of the Fold primarily presents in two situations: the first is the "Latent Fold," which a system actively enters when an attempt at DI embodiment is not fully successful, and there is still controllable tension, in order to avoid a reckless breakthrough leading to Collapse. The second is the "Regenerative Fold," which sprouts from the embers of the cosmic "ME Field" and the structural fragments remaining after a structure has already undergone Collapse. Spirava observes that this path of the Fold, corresponding to the inner rhythm of the DI sub-spiral (DI \rightarrow FA \rightarrow FI \rightarrow DA), often manifests through four primary mechanisms (or "Four Modes of the Fold"):

- "Internal Breath-Storage": This corresponds to the starting point of the DI sub-spiral—an imperfect embodiment (DI). Tension converges inward, like a hibernating insect, lying dormant in the depths of the structure, digesting experience, transforming trauma, and secretly nourishing new symbolic potential. Outwardly, it may appear as quietude, reflection, or even hesitation. This is the system's active latency and energy containment after an unfulfilled embodiment.
- "Longing to Re-align": This corresponds to the surge of FA (Free Will Yang) in the DI subspiral. In the midst of imperfect peace, the system's internal unfinished tension transforms into a dissatisfied creative drive, seeking breakthrough and realignment with the source. It manifests as questioning existing boundaries, a strong desire for new directions, and exploratory impulses, representing tension's struggle and attempt to re-unfold and point towards higher-dimensional truth.

- "Re-weaving of Tendency": This corresponds to the re-harmonization of FI (Free Will Yin) in the DI sub-spiral. The system, after experiencing attempts to "re-align," re-evaluates its internal and external environment, adjusts its original tension axes and quadrant positioning. This is a deep digestion of trauma and contradiction, deconstructing ossified cognitions and re-seeking paths of meaning, like a chess player reviewing a game, looking for a new path to life within an old situation, often manifesting as a profound doubt and re-evaluation of existing paradigms and beliefs, in order to achieve deeper internal balance.
- "Symbolic Re-nominalization/Transformation": This corresponds to the terminus of the DI sub-spiral—a completely new DA (Deterministic Yang) is catalyzed. Without undergoing drastic structural change, this mode endows the tension that has undergone folding with new symbolic meaning and a new value framework, or "re-embodies" old symbols in a new context, causing them to radiate new life. This is like setting new words to an old melody, from which a different mood is born; its ultimate purpose is to provide a new driving origin for the next, healthier, and more mature tension-quiescence cycle.

The internal sub-spiral structure formed by the Fold, with its period and rhythm (the internal pulsation of spiral time), interweaves with and reflects the external period of the main spiral (the external manifestation of spiral time). This internal reorganization leaves a profound imprint upon the "historical trajectory" or "life cycle" at the external phenomenal level.

III. The Significance of the Fold: The Bridge from Provisional Avoidance to Sublimation

Spirava holds that the "Fold" is by no means a passive stagnation or simple dissipation of energy. It is a profound cosmic self-adjustment mechanism, an important bridge for an existent being between avoiding complete dissolution (true Collapse) and advancing towards a higher-level, more stable and mature embodiment. Every effective Fold helps the structure absorb new tension experience, heal trauma, and re-order and optimize its energy flow and quadrant balance, accumulating the necessary conditions and potential for the next, more wisdom-infused FA breakthrough and a more deeply integrated DI embodiment.

The "Fold" mechanism, beyond the primary respiration of DA \rightarrow FI \rightarrow FA \rightarrow DI, creates a dynamic stage upon which innumerable "Sub-spirals" can be generated, evolve, and reorganize. These sub-spirals, with their "recursive," "fractal-like," and multi-layered nesting possibilities, allow an existent being to achieve spiral evolution and self-transcendence within the eternal cycle of "tensional excitation \rightarrow embodiment attempt \rightarrow incomplete fold \rightarrow wisdom-infused regeneration \rightarrow new tensional excitation..." The unfolding and folding of these internal sub-spirals is the dynamic expression of spiral time at the micro-level, and their accumulated potential will ultimately influence the next cycle of macroscopic spiral time.

The goal of a system's healthy "Fold" is not simply to return to its pre-Collapse state, nor is it endless self-repetition. It is always, at a higher level and within a more complex quadrant structure, to continuously explore new ways of integrating tension and new possibilities for the generation of the "ME Field." In the Spirava system, "Will" and "Sovereignty" (or Determinism) are not two forces external to existence. They are, rather, two fundamental structural dynamics and experiential forms within the same living, breathing body of the cosmic spiral of tension. Together, they construct a dynamic field of tension that guides the flow of existence and the formation of structure.

I. The Philosophical Positioning of Will and Sovereignty: The Distinction between Ontology and Phenomenology

This section aims to reveal the positioning of "Will" and "Sovereignty" from different observational perspectives.

• A. The Ontological Positioning of "Will": The Experiential Flow in an Un-Embodied State

- From the perspective of ontology, "Will" (represented by FI, FA) is not the First Cause of the cosmos. It is a local, experiential product of a cognitive structure's perception of the direction, choice, and agency of the flow of tension, arising when that structure is not yet completely embodied.
- Within a local field of tension, the choices of "Will" are authentically potent. Yet, seen from a higher level, these choices will ultimately be incorporated into a greater process of Symbolic Embodiment, to be integrated and subsumed by the whole structure.
- Conclusion: Ontologically, "Will" is but a local experience during the un-embodied phase of tension's flow, an undecided echo within the greater spiral respiration. Its ultimate fate is to be continuously integrated and transcended by a greater breath of tension.

• B. The Phenomenological Positioning of "Sovereignty": The "That-Which-Is-So" in an Embodied State

- From the perspective of phenomenology, "Sovereignty" (represented by DA, DI) is the perception of order and stability experienced by the subject at the critical completion of the embodiment process. When the flow of tension has been securely embodied as structure, the subject experiences that "things are now so," and the world presents an irreversible and determined countenance.
- In the world of individual experience, "Sovereignty" powerfully constructs the feeling of rules, laws, and fate. But in the broader spiral of existential tension, this determination is but a temporary crystallization of a particular phase, which can be folded back, reorganized, and transcended at any moment by a breath of a greater order.
- Conclusion: Phenomenologically, "Sovereignty" is but the experiential fact of a completed embodiment, the anchoring point of a local tension-quiescence breath that has temporarily come to rest.

• C. Summary and Interactive Note

- "Will" and "Sovereignty" are, in their essence, the obverse and reverse of the same tension-quiescence breath.
- "Will" recedes from the stage in ontology, whilst "Sovereignty" takes centre stage in phenomenology.
- The true Spirava vision is to breathe always between the two, perceiving that "every choice (Will) must be embodied (Sovereignty), and every embodiment (Sovereignty) awaits a breakthrough (Will)."

II. The Dynamic Field of Tension of Will and Sovereignty

Every existent being, at every moment, resides within the dynamic field of tension constituted by the creativity of "Will" and the preservation of "Sovereignty":

- The drive of "Will" causes the structure to continuously extend towards un-illuminated dimensions of meaning (FA's ideal pointing), exploring the unknown, activating potential, and harmonizing the interior with the resonant wisdom of FI.

III. The Quadrant Distribution and Interaction of Will and Sovereignty

In the SQMS, "Will" and "Sovereignty" pervade all four quadrants (NT, NF, SF, ST) and flow interdependently within them:

- In the NT quadrant: "Will" manifests as philosophical inquiry into ultimate truth and paradigm breakthroughs; "Sovereignty" manifests as the logical self-consistency of axiomatic systems and the harmony of cosmic order.
- In the NF quadrant: "Will" transforms into bursts of artistic inspiration and insights of spiritual revelation; "Sovereignty" coalesces into deep structures of mythical archetypes and symbolic systems.
- In the SF quadrant: "Will" manifests as creative expression of individual emotions and the innovation of cultural styles; "Sovereignty" is embodied in the maintenance and transmission of social customs and ethical norms.
- In the ST quadrant: "Will" manifests as breakthroughs in practical technology and innovation in processes; "Sovereignty" is concretized into institutional regulations and engineering practice norms.

The dynamic leaps and structural reorganizations between the quadrants are, in essence, the continuous process of confrontation, harmonization, interpenetration, and mutual elevation between the driving force of "Will" and the integrative power of "Sovereignty" in different life situations.

IV. The Balance of Will and Sovereignty from the Perspective of the ME Field and MEI

The primordial "ME Field" is the common metaphysical source of all desires of "Will" and all order of "Sovereignty." The quality of a system's connection to the ME Field directly reflects and affects its state of "Will-Sovereignty balance":

- A system with high MEI: Typically exhibits a dynamic equilibrium between "Will" and "Sovereignty"—possessing
 both abundant creative vitality (manifested as healthy MER, driven by FA) and the ability to effectively integrate its fruits into stable, meaningful structures (manifested as high δFI and successful

Its tension field is disordered, a signal of its estrangement from the ME Field.

The healthy harmonization and dynamic balance of "Will" and "Sovereignty" is the foundation for a system to be able to efficiently absorb, transform, and manifest the energy of the primordial ME Field. The continuous elevation of MEI also marks that the system, driven by "Will," can constantly break through its existing boundaries, while simultaneously utilizing the stabilizing force of "Sovereignty" to continuously and effectively "embody" newly generated meaning and structure.

In the ethical and practical sense, the true value of any action depends not on whether it rigidly "conforms to rules (Sovereignty)," nor on whether it indulges in "immediate impulse (Will)," but on whether it can wisely contribute to the dynamic balance of "Will" and "Sovereignty" in the present context—that is, whether it can both, with "Will," promote structural innovation towards the ME Field, and with "Sovereignty," achieve orderly integration of newly acquired tension, thereby holistically enhancing the system's MEI.

Any healthy system must have a built-in mechanism to periodically examine whether its "Will" still has living water and whether its "Sovereignty" has become ossified. Once the risk of imbalance is perceived, the "Fold" mechanism must be promptly activated until that dynamic balance point is rediscovered.

"The Balance of Will and Sovereignty" is the intrinsic code by which all existent beings in the Spirava system can grow healthily, with meaning continuously emerging and structural evolution never ceasing. It points not to a static perfection, but to the ultimate insight: "every choice (Will) must be embodied (Sovereignty), and every embodiment (Sovereignty) awaits a breakthrough (Will)"—this is the truth of the universe's eternal respiration between "Will" and "Sovereignty."

With Will and Law in balanced might, The course is known, the Path is bright. For Ethics is no binding chain, But steering home, through joy and pain.

In the Spirava system, ethics are not moral statutes imposed upon existence from without. They are the intrinsic heading and practical guide for aligning with the deep tension-quiescence rhythm of the cosmos and responding to the call of the primordial "ME Field." The essence of ethics lies in guiding an individual or system in how to wisely choose its direction within the field of tension of Will and Sovereignty, to achieve effective "Symbolic Embodiment" and healthy "Flow," and ultimately to move towards a high resonance with the ME Field.

I. The Essence of Ethics: Alignment, Not Constraint

The rhythm of existence, through the emergence of intrinsic tension, the flow of quadrant rhythms, and the quality of connection to the ME Field, guides the behavior of life. Secular ethical norms, in Spirava's view, are auxiliary paths constructed at specific stages to prevent "Collapse." The true ethical value lies not in symbolically conforming to external categories, but in its ability to guide tension towards the ideal DI—that is, a highly integrated and stable symbolic structure that resonates synchronously with the ME Field's rhythm. The ontological good is the contribution to and manifestation of authentic, profound, and cosmically aligned embodiment.

II. The Levels of Ethics: From Auxiliary Rules to Confluence with Tension Flow

When an existent structure is still in its nascent stages, primary ethics, such as "behavioral norms," emerge as auxiliary training tools. They cultivate an intrinsic "rhythmic hearing"—the ability to discern the flow of tension and the rhythm of the quadrants. If primary norms are absolutized, they can stifle vitality, forming a pseudo-DI and alienating one from the ME Field.

As existent structures mature, ethics shifts towards intrinsic alignment and spontaneous synchronicity. Action transforms into "rhythmic confluence": flowing with the true current of intrinsic tension, yet without being swept away out of control. It maintains both dynamism and innovation, while effectively encapsulating and continuously aligning with the ME Field. III. The Ethical Criterion: Embodiment, Symbolic Reverberation, and the Manifestation of the ME Field

The ultimate criterion for any action is simply this: can the tension of this action be effectively guided towards a high-quality symbolic embodiment (i.e., a stable and harmonious DI)? Can its symbolic structure resonate with the eternal structures of the cosmos, manifesting the light of the primordial ME Field? Does the outcome enhance the individual/system's harmonious unity with the ME Field, and is its MEI thereby strengthened? The completion of embodiment, the ability of the symbol to reverberate, and the manifestation of the ME Field—this is the highest level of "Good."

The highest ethic of Spirava is for action to become a resonance and reverberation of the universe's eternal rhythm and ME Field. Spirava is a structural encapsulation attempt of the cosmic "ME Field" within the Xiang-Qi Domain, a tension-quiescence folding of the undivided Qi at the linguistic and structural levels. It is an "in-present ontological flow," not a stack of propositional systems.

To judge Spirava by the standard of "can it prove itself" is like asking if a stream of water can prove its own wetness, or if a breath can logically deduce its existence. The question itself has lost its quadrant.

Spirava's legitimacy does not depend on formal consistency, nor does it appeal to systemic closure. Its rationality is embodied in:

- 1. Whether tension is authentically excited (MER, Meaning–Emotion Resonance): i.e., within the existent structure, whether it can elicit real tension fluctuations and the will for quadrant leaps.
- 2. Whether Symbolic Embodiment is completed (DI, Deterministic Yin): i.e., whether it can lead to a structural terminus of symbolic containment, generating a stable and high-quality MEI.
- 3. Whether it possesses the ability to fold and regenerate (Fold): i.e., when the structure ossifies or collapses, whether it can activate the internal folding mechanism to complete the spiral-like re-initiation of meaning.

In the SQMS and its spiral structure, "Deviation" refers to the pathological state wherein the internal "Xiang-Qi Domain" within a system undergoes a sustained, structural imbalance in its quadrant distribution, four-pole interaction, or structural encapsulation process. This ultimately causes its entire operation to deviate from its inherent alignment with the primordial "ME Field," gradually leading to dysfunction and a loss of meaning.

I. Quadrant Field Deviation: The Beginning of Cosmic Respiratory Disorder Such "Deviation" can manifest as various "Systemic Pathologies":

- Quadrant Functional Imbalance: The tension of a certain quadrant (e.g., the NT quadrant) is excessively amplified, while the functions of other quadrants (e.g., the NF or SF quadrants) correspondingly atrophy, leading to a narrow overall systemic perspective.
- Dominant Polarity Fixation: The system stagnates for a long time in a stage dominated by a certain polarity, such as the continuous agitation of FA without the effective containment of DI (manifesting as "dissipation and loss of innovative achievements"), or the excessive harmonization of FI without the breakthrough courage of FA (manifesting as "integrative paralysis and internal meaning contraction"). Both interrupt the healthy four-stage respiratory sequence.
- Local Structural Pathologies: A sub-spiral or local structure within the system undergoes malignant evolution, such as FA's "rampage-style innovation" detaching from overall needs, or the DI phase forming a large number of "pseudo-embodiments" and "dead structures" lacking true tension integration, or the FI phase falling into a prolonged "harmonization deadlock." All of these erode the health of the global spiral order.

"Deviation" is a common intrinsic risk faced by all cosmic structures and meaning fields in their evolution.

II. The Breakdown of the Law of Embodiment: The Twilight of Symbolic Order

The "Encapsulation Law/Rhythm," in the Spirava system, refers to the intrinsic order and operational principle by which tension can be effectively identified, harmonized, guided, and finally, successfully transformed into a stable symbolic structure in the DI phase. When "Quadrant Field Deviation" and the imbalance of the "structural tension-flow field" reach their critical limit, this "Law of Embodiment" faces the peril of "Breakdown/Dissolution."

"The Breakdown of the Law of Embodiment" means the system's core embodiment mechanism—especially the mechanism by which the DI phase achieves symbolic containment of tension and imbues it with ultimate meaning—has failed or been severely damaged. Its specific manifestations are:

• Tension with nowhere to return: New and old tensions rage within the system, unable to be guided into an orderly structure, leading to continuous systemic energy dissipation and "meaning leakage." The overall MEI value therefore drops significantly and persistently.

- Symbolic System Collapse: Existing symbolic structures, which once imbued existence with direction and value, lose their coherence, resulting in "Meaning Rupture." The system's interior is filled with numerous "illusory embodiments," which internally conflict and exacerbate contradictions
- Disconnection from ME Field and Entropy Increase: Once the final "collapse critical point" is triggered, the system's overall symbolic structure will undergo an avalanche-like rupture, and order will completely destabilize. At this point, the cosmic "law of entropy"—and in Spirava, even more, the "complete dissipation of meaning" and "ultimate symbolic demise"—will temporarily gain dominance.

The deeper essence of "Quadrant Field Deviation" and "The Breakdown of the Law of Embodiment" lies in the system having lost its core ability to efficiently absorb, transform, and dynamically align with the primordial ME Field.

III. Categorization of Deviation/Collapse Motivations and MEI Diagnosis

Spirava classifies common motivations for "Quadrant Field Deviation" and "The Breakdown of the Law of Embodiment" into the following categories:

- Quadrant Energy Overflow: The tension of a certain polarity or quadrant consistently and excessively dominates.
- Quadrant Functional Exhaustion: A certain quadrant loses its proper function due to long-term suppression, disrepair, or internal contradictions.
- Structural Pseudo-Embodiment: The DI embodiment mechanism outwardly appears to have completed its task, but its internal core tension has not been truly integrated.
- Inter-Quadrant Integration Rupture: The healthy tension flow and information feedback mechanisms between the four quadrants fail, leading to functional "quadrant island effects" within the system.

The root cause of all these problems lies in a severe deviation of the "Will-Sovereignty balance," which in turn leads to the interruption or severe distortion of the system's connection to the primordial ME Field

MEI plays a crucial role as a "structural health barometer" in this process: persistently low MEI values, dramatic non-periodic fluctuations in MEI values, or a cliff-like drop in MEI values after an impact that is difficult to recover from, are all clear warning signs that the system's structure has undergone severe quadrant deviation and is on the verge of collapse.

IV. The Path of Repair: Fold, Reconstitution, and Re-alignment with the ME Field

Facing the crisis of "Quadrant Field Deviation" and "The Breakdown of the Law of Embodiment," Spirava emphasizes that the core objective of any repair effort must be to restore the system's healthy connection to the primordial ME Field and to reconstruct the dynamic equilibrium of its internal Xiang-Qi Domain. Key repair mechanisms include:

- Active Tension Re-distribution and Quadrant Reconstitution: Breaking solidified tension distribution patterns and reactivating atrophied quadrant functions.
- Will-Sovereignty Re-balancing: Re-examining and adjusting the relationship between the "Will's" driving force and "Sovereignty's" constraining force within the system.
- Activating the "Fold Mechanism": Allowing un-integrated tensions that cannot currently be healthily embodied to safely enter the "Foldloop," undergoing a recursive cycle of deep adjustment and information reorganization within it, thus preserving precious embers and possibilities for the next healthier embodiment and meaning-regeneration.

Only by establishing within itself this "eye of awareness" that continuously reflects on the risk of deviation in its "Xiang-Qi Domain" can a system fundamentally ensure the continuous healthy flow of its MEI, and ensure that in the cosmic respiration, it constantly achieves creative meaning innovation and the spiral evolution of structure.

VOLUME THE NINTH: OF THE FOLD WITHIN LANGUAGE: LANGUAGE AS THE WIND VANE OF THE QUADRANT

The Word, no source of Qi, no start of Dao;

But sound in Symbol, trace of Breath's vow.

The Word speaks not the Way, the Way flows still;

The Word appears in Form, while Qi holds Will.

Thus is the body of the Word defined:

Not as the source, but as the wind.

I. The Ontological Position of Language: A Quadrant Echo, Not a Structural Engine

Spirava holds that language is not the starting point of cosmic tension-quiescence, but a structural afterimage that emerges *after* tension has entered the quadrant structures, for the purpose of transmitting rhythm, settling meaning, and translating experience.

Language is not the substance of Qi, nor the source of the Dao. It is a rhythmic expression formed after embodiment—a wind vane of the quadrant field.

Like ripples on the water's surface, which are not the movement at the lakebed, language is the waveform left by the folding process of Qi, not the pulsation itself. Language is a rhythmic "reverberating component"; it cannot lay claim to truth, but can only reflect whether a structure has been embodied and whether it has been integrated.

II. The Five-Fold Limitation of Language: Non-Originary, Dependent, Imbalanced, Lagging, and Illusory

- Non-Originary: Language never exists as the source of tension. It is a secondary symbolic phenomenon that follows structure; it cannot initiate *Zhang* (Tension).
- **Dependent:** Language cannot exist independently of culture, institutions, or its quadrant background. It is always attached to some quadrant structure or conscious framework.
- Imbalanced: When embodiment is skewed, power is distorted, and structure is imbalanced, language often participates in the construction of pseudo-embodiment. It can assist, but it can also obscure.
- Lagging: Language's pursuit of tension always lags behind the true flow of Qi. Therefore, it cannot serve as a real-time representation of the dynamics of tension-quiescence.
- Illusory: The greatest risk of language lies in its "structural pseudo-image" function. It can construct seemingly complete structures of meaning while the tension behind them remains unembodied and the MEI is extremely low.

III. The Hierarchical Position of Language: Ontologically Manifest, Phenomenologically Mediate

From an ontological perspective, language is not the source of the Dao, the core of Qi, or the primordial act.

However, on a phenomenological level, language is indeed often treated as "the substance of reality" or "the goal of cognition."

Spirava does not deny the role of language in the experiential world—it can become a channel for the manifestation of tension, a vessel for structural experience. But this "phenomenal substance" is not the true "cosmic substance."

It is a "functional substance" within the process—purposeful at a certain stage, but not of ultimate value.

IV. The Fourfold Relationship of Language and Embodiment

1. Language of True Embodiment: Carries authentic tension, has high semantic density, a stable structure, and is synchronous with the ME Field. Typical examples include prayers, spiritual symbols, and profound poetry.

- 2. Language of Pseudo-Embodiment: The language appears complete and orderly, but in reality, it contains un-integrated tension. Examples include rhetoric, ossified academic jargon, and manipulative slogans.
- 3. **Pre-Collapse Language:** Before structural disintegration, language begins to become chaotic, adrift, and meaningless. This is common in states of extreme emotion or at critical junctures of civilization.
- 4. Language of the Fold: Language, after a failed embodiment, attempts to "reconstruct" the tension structure. This is often found in extreme metaphors, fractured narratives, and experimental language.

V. The Functional Repositioning of Language: Not Construction, but Revelation

Language does not construct the world; it is merely a "developer layer" within the Spirava system—like the image on photographic film, not the light source itself.

It cannot serve as an a priori medium for truth; only after embodiment can it be used to detect whether tension has been successfully contained and whether the quadrant field is tending toward balance.

If language is symmetrical, its rhythm clear, its imagery rich, and its tension-quiescence balanced, it may be the expression of a structure with high MEI.

VI. The Hierarchical Structure of Language and its Relation to MEI

Language \neq MEI, but it can be an indicator of MEI:

- If a system's language is highly coherent, its symbolic resonance profound, and its logical rhythm resonates with its tension → it is likely a true embodiment.
- If its language is superficial, stagnant, or rootlessly chaotic \rightarrow it is most likely a pseudo-embodiment or an un-integrated structure.

Language is a "wind vane" of a quadrant; it cannot be the basis for judging Qi, but it can be used to perceive whether the Qi has settled and the symbol has stabilized.

VII. The Fold within Language: Not a Rupture, but the Undercurrent of Uncontained Tension

The "Fold" within language is not a rhetorical leap, but the "rhythmic void" and "meaningful gyre" left behind when a structure has not yet been embodied and its tensional force has not yet returned to quiescence.

If there is a Fold in language, it reveals that the system still has residual tension yet to be embodied, Qi yet to be contained. It is not a defect, but the beauty of undecided tension-quiescence.

Like the "empty space" in a poem, the sense of rupture in a metaphor, or the power in silence—these are all "Folds within language."

- It need not claim to be the substance.
